Dear Mercer County Voter:

A new law was recently enacted in New Jersey which requires our office to send you a Vote-By-Mail Ballot for the upcoming General Election on November 6, 2018, due to the fact that you requested and received a Vote-by-Mail Ballot in the 2016 General Election. This new law also mandates that our office automatically issue you a Vote-By-Mail Ballot for ALL FUTURE ELECTIONS, unless you inform our office in writing that you do NOT wish to receive a Vote-by-Mail Ballot for all future elections. Therefore, if you do not wish to receive a Vote-by-Mail ballot for the upcoming November 6th election, and all future elections, please detach and sign the statement attached in this post card, and mail it to my office by September 14th, 2018.

If you do not opt out by notifying this office in writing that you do not wish to Vote-by-Mail by September 14th, you will be sent a Vote-by-Mail ballot for the November Election and you will only be allowed to vote by mail, or by provisional ballot in November and going forward without written notice to the contrary. This is in accordance with Public Law, S647, 2018.
