TITLE

AN ORDINANCE AUTHORIZING THE CHANGE IN NAME OF THAT CERTAIN ROADWAY IN THE TOWNSHIP OF HAMILTON WHICH IS PRESENTLY KNOWN AS HORIZON CENTER BOULEVARD WHICH SHALL HEREAFTER BE NAMED AS FIRST RESPONDERS WAY

Whereas a request has been made by Integrity Health that the Township of Hamilton ("Township") consent to the re-naming of that certain roadway located in the Township between Horizon Drive and New Jersey State Highway Route 130 which is presently known as "Horizon Center Boulevard", to hereafter be known as "First Responders Way"; and

Whereas the Township has received approval from Horizon CTR, LLC, for this request, as Horizon Center Boulevard is a private roadway; and

Whereas the United States Postal Service has approved the name change; and

Whereas the Township Fire and Police Divisions, as well as the Departments of Public Works and Community and Economic Development have reviewed and approved the name change; and

Whereas the Council of the Township of Hamilton is supportive of the intent to re-name said roadway;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that a certain roadway located in the Township between Horizon Drive and New Jersey State Highway Route 130 which is presently known as "Horizon Center Boulevard", to hereafter be known as "First Responders Way".

Be It Further Ordained that hereafter on any maps or other documents on which the aforesaid roadway is shown, that it shall be identified by the new name of "First Responders Way".
