**AN ORDINANCE AUTHORIZING THE TOWNSHIP OF HAMILTON TO ACCEPT A GIFT FROM JERSEY PRECAST FOR THE DONATION OF MATERIALS TO BE USED BY THE HAMILTON TOWNSHIP FIRE DIVISION FOR TRAINING PURPOSES**

*Whereas* on January 1, 2021, the Township of Hamilton ("Township") established the Hamilton Township Fire Division ("Fire Division") under its Department of Public Safety; and

*Whereas* Fire Division personnel engage in training exercises on a regular basis; and

*Whereas* Jersey Precast has generously offered to donate several materials, including temporary barriers, 2" pipe, and cement blocks, to the Township to be used by the Fire Division for training purposes; and

*Whereas* Jersey Precast has also provided the Township with a cost estimate for the donated materials, which total \$7,750.00; and

*Whereas* the Township wishes to accept the generous gifts from Jersey Precast and memorialize their donation of materials to be used by the Fire Division for training purposes; and

*Whereas* N.J.S.A. 40A:12-29 states in relevant part that any municipality may accept donations, by gift, bequest, or devise, of real property, funds, personal property, in-kind items, or services by private persons to the soliciting governmental entity, for the purpose of the maintenance of public parks, and that any solicitation for a donation of \$7,500 or more in value shall be made a matter of public record by the municipality by adoption of an ordinance authorizing the solicitation; and

*Whereas* the authorization of the aforementioned acceptance of this donation is in the best interest of the citizens of the Township;

*Now, Therefore, Be It Ordained* by the Council of the Township of Hamilton in the County of Mercer and State of New Jersey, that the proper officials of the Township of Hamilton be and hereby are authorized to accept the donation from Jersey Precast and memorialize their donation of materials to be used by the Hamilton Township Fire Division for training purposes through this Ordinance.
