ORDINANCE AUTHORIZING THE DEDICATION OF A RIGHT-OF-WAY FOR A PORTION OF JUSTICE SAMUEL ALITO JR. WAY FROM PRIVATE TO PUBLIC TO ACCOMMODATE THE PROJECT FREEDOM "FREEDOM VILLAGE AT HAMILTON"

Whereas the Township of Hamilton has presented a Deed of Right of Way Dedication to itself for public use for a portion of Justice Samuel Alito Jr. Way described by the land survey dated September 30, 2019 by Land Map, Inc. Professional Land Surveyor Vincent J. Rigelon, Jr. attached hereto; and

Whereas the Council of the Township of Hamilton deems it to be in the best public interest of the Township of Hamilton to accept the above mentioned deed;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Deed of Right of Way Dedication, as presented to the Township of Hamilton for public purposes, be and hereby is accepted;

Be It Further Ordained that the Municipal Clerk be and hereby is authorized to record same in the Office of the Clerk of Mercer County and to plot said deeds in the Township of Hamilton Engineer's Office.
