**ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE III, TRAFFIC REGULATIONS, § 485-25, ROUTES FOR TRUCKS OVER \_\_\_\_\_ TONS; AND § 485-27, TURN PROHIBITIONS**

*Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Chapter 485, Vehicles and Traffic, Article III, Traffic Regulations, § 485-25, Routes for trucks over \_\_\_\_\_ tons, and § 485-27, Turn prohibitions*, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article III – Traffic Regulations**

.....

**§ 485-25. Routes for trucks over [ \_\_\_\_\_ ] four (4) tons.**

Pursuant to N.J.S.A. 40:67-16.1 and N.J.A.C. 16:32, both as may be amended, the streets or parts of streets as described [in the subsections below] are hereby designated as routes for vehicles having a total combined gross weight of vehicle plus load, in excess [over \_\_\_\_\_] of four (4) tons. All trucks having a total combined gross vehicle weight (GVW) of vehicle plus load in excess of [ \_\_\_\_\_ ] four (4) tons [shall] may be excluded from [all] any streets, except from those streets listed below which form a part of the system of truck routes. Vehicles will be permitted on all streets for the purpose of the pickup and delivery of materials.

- A. The National Network which includes but is not limited to Interstate 295, and Interstate 195;
  - B. The New Jersey Access Network which includes but is not limited to U.S. Route 1, U.S. Route 130, U.S. Route 206, parts of State Road 33/ County Road 618/Nottingham Road (exclusive of the section referred to in § 485-26), State Road 129, State Road 156, County Road 524, County Road 533 and County Road 535.

**§ 485-27. Turn Prohibitions.**

- A. No person shall turn at the below described locations as indicated.

B. No vehicle with a length of forty-five (45) feet or more may turn from Sweetbriar Avenue (County Road 649) to Rutgers Avenue, Trinity Avenue, Vetterlein Avenue, Leigh Avenue and Sandalwood Avenue. No vehicle with a length of forty-five (45) feet or more may turn from Bucknell Avenue to Leigh Avenue, Sandalwood Avenue and Princeton Avenue. Vehicles with a length of 45 feet or more are excluded from Rutgers Avenue, Trinity Avenue, Vetterlein Avenue, Leigh Avenue, Sandalwood Avenue. This subsection shall not apply to emergency vehicles, government owned or government leased vehicles, vehicles making an actual pickup, delivery, providing services, or have an origin or final destination to an address along these streets or Carlisle Avenue, Boxwood Avenue, Amherst Avenue and Brown Avenue.

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

A copy of this Ordinance shall be forwarded to the County of Mercer, as Sweetbriar Avenue (CR 649) is under County jurisdiction, and a consenting resolution from the Mercer County Board of Chosen Freeholders will be required prior to recommending approval to the Commissioner of Transportation.
