AN ORDINANCE AUTHORIZING A GIFT ACCEPTANCE AGREEMENT BETWEEN THE TOWNSHIP OF HAMILTON AND PETE PALOMBI FOR THE ACQUISITION OF CERTAIN REAL PROPERTY IDENTIFIED AS A WORLD WAR II NEW JERSEY NATIONAL GUARD MONUMENT TO BE DISPLAYED WITHIN VETERANS PARK

Whereas Pete Palombi is the current owner of a monument honoring the brave Americans who proudly and nobly served their country during World War II; and

Whereas Pete Palombi has offered to donate this monument to the Township to place on display within the east entrance of Veterans Park; and

Whereas the Township is agreeable to accept this monument from Pete Palombi and place it within Veterans Park in order to honor the members of the Company "B", 113th Infantry Regiment of the New Jersey National Guard for their World War II service during September 1940 to September 1945; and

Whereas N.J.S.A. 40A:12-5(a)(1) states that any municipality, by ordinance, may provide for the acquisition of any real property, capital improvement, or personal property by purchase, gift, devise, lease, exchange, condemnation, or installment purchase agreement;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton in the County of Mercer and State of New Jersey, that the proper officials of the Township of Hamilton be and hereby are authorized to execute and sign a Gift Acceptance Agreement with Pete Palombi for the donation of a World War II monument to be displayed within Veterans Park.
