ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE III, TRAFFIC REGULATIONS, § 485-37, BUS STOPS

Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Chapter 485, Vehicles and Traffic, Article III, Traffic Regulations, § 485-37, Bus stops*, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

Vehicles and Traffic

Article III. Traffic Regulations

§ 485-37. Bus stops.

The locations described are hereby designated as bus stops. No vehicle other than an omnibus, picking up or discharging passengers, shall be permitted to occupy said location.

Along Kuser Road, westbound, on the northerly side thereof at:

Along Lalor Street (CR 650), eastbound, on the southerly side thereof at:

- e. [South Broad Street (near side)]
[Beginning at the westerly curbline of South Broad Street and extending 105 feet westerly therefrom (location 22244).]

Marshall Avenue (far side)
Beginning at the easterly curbline of Marshall Avenue and extending 100 feet easterly therefrom (location 33040).

ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE III, TRAFFIC REGULATIONS, § 485-37, BUS STOPS

Be It Further Ordained that this Ordinance shall be filed with the Commissioner of the New Jersey Department of Transportation for approval pursuant to N.J.S.A. 39:4-8.

Be It Further Ordained that a certified copy of this Ordinance be forwarded to the Mercer County Board of Chosen Freeholders for a concurring resolution.

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

This Ordinance shall become effective immediately upon final adoption and publication thereof according to law.
