AN ORDINANCE AUTHORIZING A GIFT ACCEPTANCE AGREEMENT BETWEEN THE TOWNSHIP OF HAMILTON AND THE MERCER COUNTY ITALIAN-AMERICAN FESTIVAL ASSOCIATION FOR THE ACQUISITION OF CERTAIN REAL PROPERTY IDENTIFIED AS A GULF WAR ERA MONUMENT TO BE DISPLAYED WITHIN VETERANS PARK

Whereas the Mercer County Italian-American Festival Association is the current owner of a monument representing the brave Americans who proudly and nobly served their country during the Gulf War; and

Whereas the Mercer County Italian-American Festival Association has offered to donate this monument to the Township to place on display within the east entrance of Veterans Park; and

Whereas the Township is agreeable to accept this monument from the Mercer County Italian-American Festival Association and place it within Veterans Park in order to honor the surviving Gulf War veterans still residing within Hamilton Township and Mercer County, and to honor and give a voice to the memory of those brave Americans who never returned; and

Whereas N.J.S.A. 40A:12-5(a)(1) states that any municipality, by ordinance, may provide for the acquisition of any real property, capital improvement, or personal property by purchase, gift, devise, lease, exchange, condemnation, or installment purchase agreement;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton in the County of Mercer and State of New Jersey, that the proper officials of the Township of Hamilton be and hereby are authorized to execute and sign a Gift Acceptance Agreement with the Mercer County Italian-American Festival Association for the donation of a Gulf War era monument to be displayed within Veterans Park.
