ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE III, TRAFFIC REGULATIONS, § 485-37, BUS STOPS

Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Chapter 485, Vehicles and Traffic, Article III, Traffic Regulations, § 485-37, Bus stops*, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

Vehicles and Traffic

Article III. Traffic Regulations

.....

§ 485-37. Bus stops.

The locations described are hereby designated as bus stops. No vehicle other than an omnibus, picking up or discharging passengers, shall be permitted to occupy said location.

Along Quakerbridge Plaza Drive, westbound, on the northerly side thereof at:

Along Route US 130, northbound, on the easterly side at:

a. Stanbery Way (far side) (location 32971)
Beginning at the northerly curb line of Stanbery Way and extending 100 feet northerly therefrom.

b. Between AAA Drive and South Gold Drive (mid-block) (location 30699)
Beginning at a point 365 feet north of the northerly curb line of AAA Drive and a point 135 feet northerly therefrom.

Along Route US 130, southbound, on the westerly side at:

a. South Gold Drive (far side) (location 30700)
Between the southerly curb line of South Gold Drive and extending 100 feet southerly therefrom.

b. Between North FedEx Drive and South FedEx Drive (mid-block) (location 32972) Beginning 200 feet south of the southerly curb line of North FedEx Drive and extending 135 feet southerly therefrom.

Along Sculptors Way, northbound, on the easterly side thereof at:

Be It Further Ordained that this Ordinance shall be filed with the Commissioner of the New Jersey Department of Transportation for approval pursuant to *N.J.S.A. 39:4-8*.

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

This Ordinance shall become effective immediately upon final adoption and publication thereof according to law.
