**ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF ORDINANCES,  
HAMILTON TOWNSHIP, NEW JERSEY, PART II, GENERAL LEGISLATION,  
CHAPTER 215, FEES, § 215-7, DEPARTMENT OF PUBLIC WORKS**

*Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of Ordinances of Hamilton Township, New Jersey, Part II, General Legislation, Chapter 215, Fees, § 215-7, Department of Public Works*, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 215**

**FEES**

**§ 215-7. Department of Public Works.**

A. Hamilton Township ecological facility. The following fees shall be charged by the Township for ecological facility materials and services:

<b>Material/Service</b>	<b>Fee</b>
Mulch/compost self-loaded (Hamilton residents only)	No charge
Mulch/compost by HTPW loader (Hamilton residents only)	\$10 per cubic yard
Surplus compost by HTPW loader (commercial entities)	\$[12] <u>20</u> per cubic yard
[Surplus compost over 10,000 cubic yards in a single order by HTPW loader (commercial entities)]	[\$10 per cubic yard]
Leaf disposal (Hamilton residents only)	No charge
Leaf disposal - commercial	\$[10] <u>20</u> per cubic yard
Brush disposal (Hamilton residents only)	No charge
Brush disposal - commercial	\$[10] <u>20</u> per cubic yard
<u>For any brush or leaf transactions (commercial entities)</u>	<u>\$30.00 minimum charge</u>
Tire disposal (off rims) - noncommercial (Hamilton residents only)	[No charge] <u>\$2 per tire</u>
Single stream recycling disposal (Hamilton residents only)	No charge
Oil disposal (Hamilton residents only)	[No charge] <u>\$5 fee</u>

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

This Ordinance shall become effective immediately upon final adoption and publication thereof according to law.
