ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, PART II, GENERAL LEGISLATION, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING; § 485-19, HANDICAPPED PARKING (Establishing spaces for 49 Stenton Court; 229A Wert Avenue and 919 William Street)

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II; Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

.....

§ 485-19. Handicapped parking.

.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<i>Street</i>	<i>Location</i>
<u>49 Stenton Court</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 25 feet north of Bow Hill Avenue and extending to a point 47 feet north of Bow Hill Avenue along the west bound curb line of Stenton Court.</u>
<u>229A Wert Avenue</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 38 feet east of Tennyson Drive and extending to a point 60 feet east of Tennyson Drive along the north bound curb line of Wert Avenue.</u>
<u>919 William Street</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 70 feet north of Chambers Street and extending to a point 92 feet north of Chambers Street along the west bound curb line of William Street.</u>
