ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, PART II, GENERAL LEGISLATION, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING; § 485-19, HANDICAPPED PARKING (Establishing spaces for 434 Schiller Avenue {2 spaces}; 2018 South Clinton Avenue; 2211 South Clinton Avenue and 1327 William Street)

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II; Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.

.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<u>434 Schiller Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 262 feet north of the curb line of Harrison Street and extending to a point 284 feet north of the curb line of Harrison Street on the east curb of Schiller Avenue.</u>
<u>2018 South Clinton Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 154 feet south of the curb line of Cedar Lane and extending to a point 176 feet south of the curb line of Cedar Lane on the east curb of South Clinton Avenue.</u>

<u>2211 South Clinton Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 88 feet south of the curb line of Joseph Street and extending to a point 110 feet south of the curb line of Joseph Street on the west curb of South Clinton Avenue.</u>
<u>1327 William Street Hamilton, New Jersey 08610</u>	<u>Beginning at a point 118 feet north of the curb line of Mary Street and extending to a point 140 feet north of the curb line of Mary Street on the west curb of William Street.</u>

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

This Ordinance shall become effective immediately upon final adoption and publication thereof according to law.
