ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, § 485-19, HANDICAPPED PARKING (Repealing spaces established at 23 Samuel Street by Ordinance No. 16-058 and 1413 Hamilton Avenue by Ordinance No. 16-044)

Whereas the Township of Hamilton, in the County of Mercer has received requests to repeal certain handicapped parking spaces that were established on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II, Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article II – Parking**

**§ 485-19. Handicapped parking.**

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

[23 Samuel Street Hamilton, New Jersey 08610]	[Beginning at a point 42 feet south of the curb line of Genesee Street and extending to a point 62 feet south of the curb line of Genesee Street on the west curb of Samuel Street.]
