TITLE

AN ORDINANCE AUTHORIZING THE CHANGE IN NAME OF THAT CERTAIN ROADWAY IN THE TOWNSHIP OF HAMILTON WHICH IS PRESENTLY KNOWN AS RIPPETOE WAY WHICH SHALL HEREAFTER BE NAMED AS KAY CHIARELLO WAY

Whereas the Township of Hamilton ("Township") desires to recognize Kay Chiarello, the matriarch of the Chiarello family, as a pillar of the Hamilton Township community; and

Whereas a request has been made by the Township that Sharbell Parkside, LLC, the developer of the residential development known as "Vintage at Hamilton", for consent to the re-naming of that certain roadway located in the Township intersecting Sportsman Boulevard, which is presently known as "Rippetoe Way", to hereafter be known as "Kay Chiarello Way"; and

Whereas the Township has received approval from Sharbell Parkside, LLC, for this request, as "Rippetoe Way" is a private roadway; and

Whereas the United States Postal Service has consented to the name change; and

Whereas the Township Fire and Police Divisions, as well as the Departments of Public Works and Community and Economic Development have reviewed and approved the name change; and

Whereas the Council of the Township of Hamilton is supportive of the intent to re-name said roadway;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that a certain roadway located in the Township intersecting Sportsman Boulevard, which is presently known as "Rippetoe Way", to hereafter be known as "Kay Chiarello Way".

Be It Further Ordained that hereafter on any maps or other documents on which the aforesaid roadway is shown, that it shall be identified by the new name of "Kay Chiarello Way".
