TITLE

AN ORDINANCE AUTHORIZING THE CHANGE IN NAMES OF THOSE CERTAIN ROADWAYS IN THE TOWNSHIP OF HAMILTON WHICH ARE PRESENTLY KNOWN AS LOCUST AVENUE, MAPLE SHADE AVENUE AND MARSHALL AVENUE

Whereas there are certain roadways in the Township of Hamilton ("Township"), namely Locust Avenue, Maple Shade Avenue, and Marshall Avenue, that contain duplicate house numbers and road names in two separate areas of the Township; and

Whereas in order to alleviate safety concerns and confusion during emergency events, utility services, and deliveries, the Township wishes to rename the aforementioned duplicate roadways as follows:

1. From "Locust Avenue" to "Locust Avenue East" in zip code 08620;
2. From "Locust Avenue" to "Locust Avenue West" in zip code 08610;
3. From "Maple Shade Avenue" to "Maple Shade Avenue East" in zip code 08690;
4. From "Maple Shade Avenue" to "Maple Shade Avenue West" in zip code 08610;
5. From "Marshall Avenue" to "Marshall Avenue East" in zip code 08619;
6. From "Marshall Avenue" to "Marshall Avenue West" in zip code 08610; and

Whereas the United States Postal Service has consented to these name changes; and

Whereas the Township Fire and Police Divisions, as well as the Departments of Public Works and Community and Economic Development have reviewed and approved the name changes; and

Whereas the Council of the Township of Hamilton is supportive of the intent to re-name said roadways;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that those certain roadways in the Township of Hamilton which are presently known as Locust Avenue, Maple Shade Avenue, and Marshall Avenue be and hereby are renamed as outlined in this Ordinance above.

Be It Further Ordained that hereafter on any maps or other documents on which the aforesaid roadways are shown, that they shall be identified by their new names as outlined in this Ordinance above.
