**ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, § 485-19, HANDICAPPED PARKING (Repealing space established at 141 Herbert Avenue by Ordinance No. 03-046)**

Whereas the Township of Hamilton, in the County of Mercer has received requests to repeal certain handicapped parking spaces that were established on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II, Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article II – Parking**

**§ 485-19. Handicapped parking.**

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<i>Street</i>	<i>Location</i>
[141 Herbert Avenue Hamilton, New Jersey 08690]	[Beginning at a point 227.5 feet northeast of the northwest corner of Herbert Avenue and New Jersey State Highway Route 33 and extending northeasterly to a point 22 feet therefrom.]
