ORDINANCE AMENDING AND SUPPLEMENTING THE *CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, PART II, GENERAL LEGISLATION, CHAPTER 150, BUSINESSES AND NON-PROFIT CORPORATION, REGISTRATION OF, § 150-3, REGISTRATION*

Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Part II, General Legislation, Chapter 150, Businesses and Non-Profit Corporation, Registration Of, § 150-3, Registration*, as amended and supplemented, be further amended and supplemented as follows:

CHAPTER 150

BUSINESSES AND NON-PROFIT CORPORATION, REGISTRATION OF

.....

§ 150-3. Registration.

- A. Each and every business and nonprofit corporation as defined in this Chapter shall be required annually to register with the Township Clerk. Said registration shall be on a form prescribed by the Township Clerk and shall include, among other information:
1. The name of the business or the non-profit corporation.
 2. Street address.
 3. Mailing address.
 4. Telephone number.
 5. Email address.
 6. Internet website.
 7. Name and contact information of President, Chief Executive Officer, Executive Director, owner or majority owner(s), as applicable.
 8. Name and contact information of at least one additional executive of the business or nonprofit corporation.
 9. A designation and contact information for an emergency contact.

10. Description of business or nonprofit corporation.

B. Said registration shall be completed by [July] January 1 of each year. Any new business or nonprofit corporation shall have 60 days within which to register from the date it is created, or [July] January 1, whichever comes first.

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.
