**ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING; § 485-19, HANDICAPPED PARKING (Establishing spaces for 255 Lynwood Avenue; 130 McClellan Avenue; 16 Partridge Avenue; and 1319 William Street)**

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II; Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article II – Parking**

**§ 485-19. Handicapped parking.**

B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<i>Street</i>	<i>Location</i>
<u>255 Lynwood Avenue Hamilton, New Jersey 08609</u>	<u>Beginning at a point 368 feet north of Greenwood Avenue and extending to a point 388 feet north of Greenwood Avenue along the west side curb line of Lynwood Avenue.</u>
<u>130 McClellan Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 213 feet south of Sewell Avenue and extending to a point 234 feet south of Sewell Avenue along the north side curb line of McClellan Avenue.</u>

<u>16 Partridge Avenue</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 132 feet east of South Olden Avenue and extending to a point 152 feet east of South Olden Avenue along the north side curb line of Partridge Avenue.</u>
<u>1319 William Street</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 178 feet west of the curb line of Mary Street and extending to a point 198 feet west of the curb line of Mary Street on the south curb of William Street.</u>

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.
