ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING; § 485-19, HANDICAPPED PARKING (Establishing spaces for 20 Annabelle Avenue; 22 Assumpink Boulevard; 315 Grand Avenue; 224 Klockner Road; 22 Marshall Avenue West; and 103 Samuel Street)

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, *Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of Ordinances of Hamilton Township, New Jersey*, Chapter 485, *Vehicles and Traffic*, Article II; *Parking*, § 485-19, *Handicapped Parking*, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.

.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

Street	Location
<u>20 Annabelle Avenue</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 158 feet west of South Broad Street and extending to a point 179 feet west of South Broad Street along the south side curb line of Annabelle Avenue, in front of the residence.</u>
<u>22 Assumpink Boulevard</u> <u>Hamilton, New Jersey 08619</u>	<u>Beginning at a point 61 feet south of Second Avenue and extending to a point 83 feet south of Second Avenue along the east side curb line of Assumpink Boulevard, in front of the residence.</u>

Street	Location
315 Grand Avenue <u>Hamilton, New Jersey 08610</u>	Beginning at a point 126 feet west of Lida Street and extending to a point 148 feet west of Lida Street along the south side curb line of Grand Avenue, in front of the residence.
224 Klockner Road <u>Hamilton, New Jersey 08619</u> (Space located on Collier Avenue)	Beginning at a point 61 feet east of Klockner Road and extending to a point 83 feet east of Klockner Road along the north side curb line of Collier Avenue, on the side of the residence.
22 Marshall Avenue West <u>Hamilton, New Jersey 08610</u>	Beginning at a point 150 feet south of Lalor Street and extending to a point 168 feet south of Lalor Street along the east side curb line of Marshall Avenue West, in front of the residence.
103 Samuel Street <u>Hamilton, New Jersey 08610</u>	Beginning at a point 51 feet north of Genesee Street and extending to a point 69 feet north of Genesee Street along the west side curb line of Samuel Street, just north of the residence.

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.
