ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, § 485-19, HANDICAPPED PARKING (Repealing spaces established at 1224 Deutz Avenue by Ordinance 23-001; 133 Jeremiah Avenue by Ordinance No. 21-063; 2211 S. Clinton Avenue by Ordinance 20-002; 694 South Olden Avenue by Ordinance 19-048)

Whereas the Township of Hamilton, in the County of Mercer has received requests to repeal certain handicapped parking spaces that were established on streets for private residences;

Now, Therefore, *Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II, Parking, § 485-19, Handicapped Parking*, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.

.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

Street	Location
[1224 Deutz Avenue Hamilton, New Jersey 08610]	[Beginning at a point 108 feet north of High Street and extending to a point 130 feet north of High Street along the east curb line of Deutz Avenue]
[133 Jeremiah Avenue Hamilton, New Jersey 08610]	[Beginning at a point 223 feet south of Bow Hill Avenue and extending to a point 245 feet south of Bow Hill Avenue along with west curb line of Jeremiah Avenue.]
