**ORDINANCE AMENDING AND SUPPLEMENTING THE *CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY*, CHAPTER 485, *VEHICLES AND TRAFFIC*, ARTICLE II, *PARKING*; § 485-19, *HANDICAPPED PARKING (Establishing spaces for 19 E. Franklin Street; 129 E. Franklin Street; 252 Lafayette Avenue; 201 Park Lane; and 58A Stenton Court)***

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of Ordinances of Hamilton Township, New Jersey*, Chapter 485, *Vehicles and Traffic*, Article II; *Parking*, § 485-19, *Handicapped Parking*, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article II – Parking**

**§ 485-19. Handicapped parking.**

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<i>Street</i>	<i>Location</i>
<u>19 E. Franklin Street Hamilton, New Jersey 08610</u>	<u>Beginning at a point 65 feet west of Hutchinson Street and extending to a point 83 feet west of Hutchinson Street along the south side curb line of E. Franklin Street, in front of the residence.</u>

<u>129 E. Franklin Street Hamilton, New Jersey 08610</u>	<u>Beginning at a point 194 feet east of Bergen Street and extending to a point 214 feet east of Bergen Street along the south side curb line of E. Franklin Street, in front of the residence.</u>
<u>252 Lafayette Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 192 feet west of Buchanan Avenue and extending to a point 210 feet west of Buchanan Avenue along the north side curb line of Lafayette Avenue, in front of the residence.</u>
<u>201 Park Lane Hamilton, New Jersey 08609</u>	<u>Beginning at a point 30 feet south of Walnut Avenue and extending to a point 48 feet south of Walnut Avenue along the west side curb line of Park Lane, in front of the residence.</u>
<u>58A Stenton Court Hamilton, New Jersey 08610</u>	<u>Beginning at a point 88 feet south of Bow Hill Avenue and extending to a point 106 feet south of Bow Hill Avenue along the east side curb line of Stenton Court, in front of the building.</u>
