**Summary of the Annual Plan for 2025 Program Year**

The draft 2025-2029 Five-Year Consolidated Plan and 2025 Annual Action Plan addresses and contains the Township’s housing and non-housing needs, objectives, proposed projects, and other required statements. For FY 2025, the Township expects to receive and allocate \$603,600.00 in CDBG funding, as listed below. The Township proposes to utilize its CDBG funds for the following activities:

Housing Rehabilitation Program and Administration	\$105,000.00
Public Infrastructure (Bromley Center Elevator)	\$22,000.00
Municipal Infrastructure Improvements (Parks/Streets)	\$265,340.00
Public Services (Wilson Center, Hamilton YMCA, Arm in Arm)	\$90,540.00
Grant Administration	\$120,720.00
<b>Total</b>	<b>\$603,600.00</b>
