**ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, § 485-9, PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS (Eaton Avenue)**

*Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Chapter 485, Vehicles and Traffic, Article II, Parking, § 485-9, Parking prohibited at all times on certain streets*, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article II – Parking**

**§ 485-9. Parking prohibited at all times on certain streets.**

No person shall park a vehicle at any time upon any streets or parts thereof described.
