ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING; § 485-19, HANDICAPPED PARKING (Establishing spaces for 13 Adella Avenue; 8 Charlotte Avenue; 1536 Genesee Street; 149 Joan Terrace; 56 Lafayette Avenue; 57 Lafayette Avenue; 302 Lafayette Avenue; 438 Lynwood Avenue; 473 Lynwood Avenue; 184 Main Street; 27 Parkinson Avenue; 24 Perry Avenue; and 446 Schiller Avenue)

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II; Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.

.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<u>13 Adella Avenue</u> <u>Hamilton, New Jersey 08609</u>	<u>Beginning at a point 115 feet east of East State Street and extending to a point 135 feet east of East State Street along the eastbound curb line of Adella Avenue, in front of the residence.</u>

<u>1536 Genesee Street</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 60 feet west of Joseph Street and extending to a point 78 feet west of Joseph Street along the westbound curb line of Genesee Street, in front of the residence.</u>
<u>149 Joan Terrace</u> <u>Hamilton, New Jersey 08629</u>	<u>Beginning at a point 146 feet north of Tipton Street and extending to a point 166 feet north of Tipton Street along the southbound curb line of Joan Terrace, in front of the residence.</u>
<u>56 Lafayette Avenue</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 164 feet west of Sewell Avenue and extending to a point 184 feet west of Sewell Avenue along the westbound curb line of Lafayette Avenue, in front of the residence.</u>

<u>184 Main Street Hamilton, New Jersey 08620</u>	<u>Beginning at a point 335 feet west of Church Street and extending to a point 355 feet west of Church Street along the westbound curb line of Main Street, in front of the residence.</u>
<u>27 Parkinson Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 60 feet west of Samuel Avenue and extending to a point 78 feet west of Samuel Avenue along the eastbound curb line of Parkinson Avenue, in front of the residence.</u>
<u>24 Perry Avenue Hamilton, New Jersey 08629</u>	<u>Beginning at a point 52 feet north of Sykes Avenue and extending to a point 70 feet north of Sykes Avenue along the southbound curb line of Perry Avenue, across from the residence.</u>
