ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, § 485-19, HANDICAPPED PARKING (Repealing spaces established at 199 Applegate Drive by Ordinance No. 16-058; 26 Beal Street by Ordinance No. 03-032; 395 Massachusetts Avenue by Ordinance No. 12-045; and 429 Wilfred Avenue by Ordinance No. 01-027)

Whereas the Township of Hamilton, in the County of Mercer has received requests to repeal certain handicapped parking spaces that were established on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II, Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.
.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<i>Street</i>	<i>Location</i>
[199 Applegate Drive Hamilton, New Jersey 08690]	[Beginning at a point 50 feet north of the curb line of Hughes Drive and extending to a point 70 feet north of the curb line of Hughes Drive on the west curb of Applegate Drive.]
[26 Beal Street Hamilton, New Jersey 08610]	[Beginning at a point 195 feet northeast of the most Northerly corner of South Olden Avenue and Sylvan Avenue and extending northeasterly to a point 22 feet therefrom.]

[395 Massachusetts Avenue Hamilton, New Jersey 08629]	[Beginning at a point 27 feet east of Norman Court and extending to a point 49 feet east of Norman Court on the southern curb line on Massachusetts Avenue.]
[429 Wilfred Avenue Hamilton, New Jersey 08610]	[Beginning at a point 138.5 feet northwest of the southwest corner of Wilfred Avenue and Mary Street and extending northwesterly to a point 22 feet therefrom.]

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.
