ORDINANCE AMENDING AND SUPPLEMENTING THE *CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY*, CHAPTER 485, *VEHICLES AND TRAFFIC*, ARTICLE II, *PARKING*; § 485-19, *HANDICAPPED PARKING (Establishing spaces for 51 Andrew Street; 637 Berg Avenue; 250 E. Franklin Street; 306 McClellan Avenue; 208 Norway Avenue; 16 Oregon Avenue; and 2332 South Clinton Avenue)*

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of Ordinances of Hamilton Township, New Jersey*, Chapter 485, *Vehicles and Traffic*, Article II; *Parking*, § 485-19, *Handicapped Parking*, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.

.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<i>Street</i>	<i>Location</i>
<u>51 Andrew Street Hamilton, New Jersey 08610</u>	<u>Beginning at a point 235 feet north of Bow Hill Avenue and extending to a point 255 feet north of Bow Hill Avenue along the west side curb line of Andrew Street in front of the residence.</u>

<u>637 Berg Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 220 feet west of E. Park Avenue and extending to a point 240 feet west of E. Park Avenue along the south side curb line of Berg Avenue in front of the residence.</u>
<u>250 E. Franklin Street Hamilton, New Jersey 08610 (Space located on Dunbar Street)</u>	<u>Beginning at a point 55 feet north of E. Franklin Street and extending to a point 75 feet north of E. Franklin Street along the west side curb line of Dunbar Street on the side of the residence.</u>
<u>306 McClellan Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 40 feet east of Buchanan Avenue and extending to a point 60 feet east of Buchanan Avenue along the north side curb line of McClellan Avenue in front of the residence.</u>
<u>208 Norway Avenue Hamilton, New Jersey 08609</u>	<u>Beginning at a point 50 feet east of Walnut Avenue and extending to a point 70 feet east of Walnut Avenue along the north side curb line of Norway Avenue in front of the residence.</u>
<u>16 Oregon Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 105 feet east of Dewey Avenue and extending to a point 125 feet east of Dewey Avenue along the north side curb line of Oregon Avenue in front of the residence.</u>
<u>2332 South Clinton Avenue Hamilton, New Jersey 08610</u>	<u>Beginning at a point 75 feet west of Lida Street and extending to a point 95 feet west of Lida Street along the north side curb line of South Clinton Avenue in front of the residence.</u>
